7:11 – 7:15: Introductions Members & Guests, New Residents,

7:15: Adoption of Tonight's Agenda

7:16: Approval of December 1, 2015 Meeting Minutes

- Motion to approve December 1,2015 meeting by Karl Barnes, seconded by Alethea Parker, unanimously approved 42-0, motion carries
- Question: do we need a motion to re-instate the bylaws since they were suspended last meeting?
 - Parliamentarian: No, we suspended a rule, and according to the bylaws a rule can only be suspended for one meeting and goes back into effect at the following meeting.

GUEST PRESENTATIONS

7:18 - 7:36: APD/Public Safety Report - Lieutenant Sinks, APD

- Delvin Gates was picked up for warrants, but the juvenile court system let him out the next day.
 - Crimes included burglary and criminal trespassing, and he fought a cop to get into custody.
 - He was chased down behind a store on RDA on Christmas
 - o Police did their job, but have no control over juvenile court system
 - APD working with courts to revoke probation status, but it is hard to do for a iuvenile
 - Officer Watkins is working on this
 - Wayne Grannis (Office: 404-613-4671, Fax: 404-302-8563) is the DA for juveniles, so he is the person to go to with issues in the juvenile court
- Motorcycle chase that ended on Ralph David Abernathy Boulevard (RDA)
 - o It was GA state patrol, not APD, who did the chase their rules are different.
 - o started on east side of town on I-20, ended on RDA (went all around town)
- Dirt Bikes 1 cauught by APD
 - o able to get him before he jumped on his bike, were unable to catch the others
 - Bike was impounded
- Homicide on Holderness (Preston Lewis)
 - Lt. Sinks has few details because Homicide is working on it and won't release details until they've spoken with everyone involved.
 - Lt. Sinks is checking in with them every few days, will email WEND president when he gets updates.
 - Question: Some neighbors may have info who have not been contacted by homicide. How can they get the info to APD?
 - Call CrimeStoppers because it funnels information directly to Homicide (and they'll pay you if it helps with the case!)
 - Can also be anonymous via phone
 - Email Lt. Sinks if you want to send stuff anonymously as well (he will pass it on)
 - Question: It appears the victim was in a gang we may have a problem with gang activity. Is there anything that has been discussed in terms of addressing gangs (and the affiliated crime rings, drug dealings, burglaries, etc. associated with gangs) in Zone 4?
 - Yes and no targeted enforcement (gang unit) must establish if they are a gang - who they hang out with, what they're doing – must commit a crime as a gang in order for it to be illegal
 - More challenging because it isn't always a formal gang
 - Question: Is someone following social media? Much crime activity is photographed on instagram and other social media sites (e.g. under-aged children holding guns, smoking inside Food Mart, etc.)
 - Yes, but KNOWING and PROVING are different can't prove who is doing the posting, often must have picture of the crime taking place.
 - Follow-up Q: So if a kid has warrants/charges, and they have pictures with automatic weapons, can you use that in court?

- Yes, that has been used (e.g. caught people selling stolen items like guns on facebook)
- Contact information for people in charge of gang unit:

- Comment: USE the neighbors, who are involved, and a resource
- Comment: On Fox News they had a clip of footage that a mustang was possibly related to the homicide
 - If you recognize it let the police know
- Dealing with 4-wheelers
 - o If you know something, let Sinks know, especially if it's info on where they gather before they get on their vehicles.
 - They MUST get them before they get on the bikes, because they often can't get them once they're on.
- Question: Does APD work with APS?
 - Yes, truancy officers are APD
 - o You can call 911 if you see kids you suspect to be truant
 - o APD grabs the kids, calls the truancy officer (who in a van)
 - Truancy officer is Veronica Campbell (404-756-1903)
 Any other things meet in the hall.

7:36 – 7:43: Alan Ferguson, Neighborhood Revitalization Manager, Invest Atlanta & Al Schroeder, Underwriting Manager, Vitus Group

- Asking for letter of support for underwriting of the bond through Invest Atlanta, will not get into scope of work at this meeting
- Alan Ferguson is from Invest Atlanta, the economic development arm of Atlanta
 - o Here in support of Vitus group, acquiring RDA Towers
 - Invest Atlanta likes the plan because it modernizes the building, makes it more energy efficient, and because it doesn't involve displacement of the residents while staying affordable
- Schroder from Vitus Group, here to answer questions
 - o This is an in-place rehab
 - o no changes to rent
 - o no displacement
 - o financed through the bonds
- Addressing questions that have arisen in the past
 - No Taxpayer money is involved, and it doesn't create liability to City of Atlanta or its residents
 - o Invest Atlanta only works as a bridge connecting investors with capitol with developers who need it to complete the projects
 - o Bonding has started, Vitus is the only one taking risk
- We have seen letters of support from residents, who are eager for this.
- It is a 20 year extension of the affordable housing contract with HUD so residents can stay, keeps affordable housing available for residents

- Most residents are disabled or aging
- Question: Purchase price of building?
 - o Around \$8 million
 - o Construction is \$4 million
- Question: How many competitive bids?
 - This is not city-related, it's a private sale from West Hunter to Vitus group, so no competitive bids necessary.
- Question: Will Vitus group be back to present for Urban Design Review Committee??
 - o Yes
- 7:43 motion to write a letter of support on behalf of WEND by Mallerie Shirley, Seconded by Jillian. Vote was unanimously in favor, 55-0 (2 abstentions). Motion carries

7:51 – 7:53: Beautification

- Yard of the Month: Ms. Cynthia on Oglethorpe (possibly 1129) won for best Christmas Decorations
- Beecher Street won nicest street for holiday decorations
 - o It was great to see so many decorations and carolers this year ☺

7:53 – 8:15: Education

- Dr. Faulkner presented from WestSide Ready, which represents community stakeholder and colleges representing the Washington High School cluster
 - o There's so much going on in education we need to get engaged!
 - In November, Georgia is voting on implementing an Opportunity School District (OSD), where underperforming schools can be taken over and run by the state.
 - 3 schools in potential takeover list are IN OUR CLUSTER
 - The state could take over a school building, but still charge local taxpayers to upkeep the building
 - This takes money from APS
 - All high schools on the south and west sides of ATL are on the list, and being taken over would bust up these clusters
 - Washington High School is on the list despite higher scores because the state has ruled that when two schools merge, the school takes on the lower score of the two
 - This is especially critical because Washington High School was the first high school built by and for African Americans, as a direct link to AUC (Atlanta University Center)
 - Officially, APS board members cannot oppose this
 - Under OSD, the governor appoints a principal, not necessarily based on qualifications.
 - The school could also be run by a different municipality (e.g. Cobb County schools could run a currently-APS school)
 - This is on the state-wide ballot, so even communities who will not be affected get to vote on this.
 - No schools have been taken over yet by the state because the law isn't in effect, although the legislative groundwork has been laid so they can get started right away
 - A school would be place in the OSD for 5-10 years.
 - APS is transitioning to a charter cluster model (different from Charter Schools)
 - Jan 30th there will be a West Side education forum at Kennedy Middle School (225 James P Brawley Dr NW) – learn more and ask questions and give input.
 - Find information on West Side Ready's facebook page and website for more information.

- CHILDCARE WILL BEAVAILABLE
- THEY WILL PROVIDE TRANSPORTATION
- FOOD WILL BE PROVIDED
- They're taking volunteers if you're interested.
- Working to bring folks from NOLA and Tennessee to talk about the effects of OSD (with data) where this has already been done
- Ouestion: does West Side Ready support Vocational Tech?
 - Westside Ready doesn't focus on this. Washington cluster is STEM, but also conversations about teaching vocational tech.
 - Atlanta Area tech is partnering with APS to include Voch Tech across APS
- Renovation of Brown
 - December 2016 move date, NOT the summer as hoped for
 - New programs, likely new leadership charter systems desire different types of leaders
 - Byron Amos will inquire about water issues around Brown, including building of retention pond, new pipes, and what else is going on.
- o APS is about to start its own police public safety force
 - APS will be removed from schools, replaced by APS resource officers
