Mostly seeing residential burglaries (appliance theft),

Auto thefts are up, but this is likely due to the theft occurring in other zones and then the stolen vehicle is driven into Zone 4.

All other crime stats are reportedly down.

 - Drug sales at 1107 RDA are increasingly an issue
 - Concerns about response times to burglaries
 - Concern about the panhandling/begging at the 20 entrance/exit ramps.
 What plan is the plan to curb aggressive panhandling? (Notes as a Quality of Life Unit APD issue).
 - Concern over stolen packages off porch. Video footage and photos of the incident. Police reported to ask the victim "Do we really have to file a report?" The response does not seem adequately concerned with the crime.

YouWork (John Mitchell): Just wrapped up several weeks of workshops with the kids involved. Moving forward, kids are now at the point to be able to interview with the prospective internships to start the internships over the next 6-8 weeks of the program. Local businesses include West End print shop, Koinonia Coffee, Good Hair Shop, Area West, West End Soccer in the Streets, Clutch Bike Shop, and Hammonds House.

11 kids total participating. Accepted 15, but some have dropped off.

Placemaker's Grant: (No new updates) The Placemaker's Committee recently met with Stream Realty (owners/developers of Lee + White) and City representatives to discuss the planned mural project at the intersection of Joseph E. Lowery and White. Stream/Lee + White have said they don't have any conflicting plans for the intersection (curb cuts, etc) and will support whatever the neighborhood/committee wants to do. We are waiting on some information from the City on survey and financial planning and will begin reaching out to artists in the next few months(ish). There are plans for another community meeting for community feedback and input.
