- Natalie Hall Fulton County Commissioner
  - The Commissioner's Office is working on a comprehensive plan to address homelessness. There has been a rise in homelessness across several demographics in recent years. Most important to the commissioner is for Fulton County and City of Atlanta to partner to address and combat homelessness, including an increase in homelessness among GSU and Georgia Tech students. It was mentioned that often times homeless individuals are resistant to moving and coming in from outside. The homeless population is transient. The Commissioner's Office is increasing their data tracking and working on bolstering their homeless strategy. The goal is not to "clear out" homeless encampments, but rather connect those individuals with nonprofit resources.
  - Neighbors have requested we upload the commissioner's plan and resources to Wend Website.
  - Board of Assessors Assign fair market values to each home. Robert Comer is the person West End residents should address questions to about appraisal values. Assessments will come out in late May or early June. Residents are encouraged to appeal their tax assessment notice if they have any concerns about the appraisal value.

- Placemaker's Grant
  - Great updates! Last year, WEND received a \$50,000 grant to create murals on the corners of White and Lowery and White and Hopkins. Murals will be approximately 70 by 40 ft. City will use high quality materials to ensure they are road safe and durable.
    - Elaine Stephenson Her design will be located right across from the Lee & White Complex. She is a Graphic Designer at CARE and Atlanta Native, passionate about typography and lettering.
      - Option 1: Derived from the Blocks of Culture Sign. Describes community.
      - Option 2: Focuses on the West End Name.
      - Option 3: Combines options 1 and 2, highlights West End name and descriptors of the community.
    - <u>Craig Singleton</u> C. Flux Sing, Painter, illustrator, graphic designer and muralist. Worked hard to include important historical narrative of the Wet End.
      - Option 1: Depicts abstract colors across the blocks of culture
      - Option 2: A more literal depiction of the "blocks" of culture
      - Option 3: Wove colors from the Blocks of Culture sign together in an abstract way – circle in center represents the womb from which greatness was born in the West End.
  - Community Feedback: Include 1835 on designs. Make noun/adjective consistent on Elaine's designs. Questions about whether words will be legible from street.
