GUEST PRESENTATIONS 7:05 – 8:25

Mallory Shirley – 690 Grady Place Variance Request

- Requesting a rear yard setback to 0 ft for ADU in order to construct staircase on ADU.
- There is no alleyway on the land survey.
- She has support from neighbors who are in the process of adding an 8 ft privacy fence on top of a 3 foot wall.
- She has a nonconforming lot.
- There is no easement on the property that the property would sit on.
- Questions were raised about the placement of the ADU, privacy concerns, and reasons for bringing setback to 0.
- Motion was to not support the variance, 12 in favor, 0 opposed, 8 abstentions.

Mia McKinney – West End LCI

- Works for Atlanta LCI and Beltline Masterplan
- Two projects run on the same track that are in the visioning stage, preparing to make recommendations to the city. Project focused on mobility updates, land use and community development.
- There is an 80% to 20% grant matching program through the West End LCI. Top importance is to preserve the history and character of the neighborhood while making it more pedestrian friendly. Beltline is focusing on Lee Street South/Oakland City and Cascade/Beecher neighborhoods. Their hope is to create economically varied retail.
- They are in the writing phase and are seeking input from neighbors. The proposal will be published in December and neighbors can provide feedback following that area.
- Proposals to participate can be submitted directly to the Beltline. Neighbor expressed concern about additional crosswalks. KIPP crosswalk will be prioritized in the immediate future.
- Neighbors expressed growing concern about traffic/speeding danger on Langhorn St. There is a 100 day plan to address concerns, but the plan is to prioritize it based on feasibility. The city can't meet all of the concerns but is aware that Langhorn is a top concern. If it weren't to be included in the plan it would likely be because of funding. Residents are encouraged to repeatedly express concerns to Beltline leadership and Atlanta City Design Office.

Kevin Maher – Place Maker Design, Z-19-095, Rezoning 1247 Ralph David Abernathy Blvd

- Building 9, 3-story townhomes on the corner of Atwood and RDA. None will be designated affordable. They will be outside of the historic district.
- Neighbors expressed concern about the size of the lot and the density.
- Architects are working with UDC and WEND preservation committee to preserve historic character of the façade.
- The current zoning is C1C, they propose going to C1
- City Planning Office suggested placing provisions under the C1C adding conditions and design controls under C1C
- Motion to support C1C with the condition that commercial uses are restricted. 18 in favor, 1 opposed, 2 abstentions.

- Rough weekend: two homicides in the West End. Intelligence and gang units are working overtime to redirect young people who need additional support. Car break-ins are high. They are implementing a new safety check system.
- There continue to be car break-ins, typically overnight
- Neighbors are asking for an increased presence on Atwood between Greenwich and Lucile as there are concerns about drug usage and prostitution. Stop and Shop at Lee and Beecher is also of concern.
- Concerns about Sells Avenue drag racing, there have been two recent hit-and-runs.
- We encourage neighbors to become more involved in the neighborhood to help mitigate crime and look out for one another
- 8 more officers were added to zone 4.
