- Canopy Atlanta, Floyd Hall and Mariann Martin

- Canopy Atlanta is a new journalism nonprofit that aims to tell stories about Atlanta neighborhoods that are otherwise overlooked. Journalists felt that there were major gaps in reporting local stories, and came together to write stories about one neighborhood at a time. West End will be the first neighborhood featured. "Local News by Atlanta, With Atlanta."
- They are hosting listening sessions with community members, to share what they felt were important issues the community is facing.
- They also offer a fellowship program to train journalists and learn the art of community journalism.
- They had planned to unveil each story through events, but that became impossible due to Covid-19.
- Residents are welcome to fill out listening forum available at Canopyatlanta.org.
- Whitney Fuller Atlanta Beltline
  - Subarea masterplan: Atlanta West End is inside of subarea 1.
  - Atlanta Beltline was developed to incorporate 10 subareas of Atlanta, from Southwest all the way around the city.
  - Between May 2019 and March 2020 there were 33 community meetings to hear and address the feedback and ideas of neighbors
  - The subarea master plan makes recommendations regarding land use, housing affordability, arts and culture, and historic preservation to the City of Atlanta
  - o Recommendations focus on safety, mobility, accessibility, economic activity
  - o Whitney will return to the August meeting to prepare for the NPU vote.

- Public Relations & Marketing
- Preservation & Urban Design
  - Slow month for the preservation committee. A few applicants have met with the committee to review plans prior to construction.
  - As a reminder, code violations that take place during Covid-19 will have to be resolved when the city reopens.
  - There are many incidents of flippers who are completing work without permits and not disclosing these fines to potential buyers: 1285 Greenwich Street, 898 Rose Circle, 1282 Lucile Avenue, 1186 Lucile Avenue, 574 Holderness Street, 1114 Lawton Place.
- Zoning, Land Use & Code Enforcement
  - Walter Slayton
  - Z-20-07 Recommendation is to support the legislation that would allow anyone who wants to build on landlocked lots (lots without street access) to do so.
    - Recommendation from committee is to support.
    - Vote: 20 in favor 0 opposed 0 abstentions. Motion carries.
  - o Z-20-36
    - Recommendation from committee is to not support the ordinance.

- NPU Dashboard is a new, interactive initiative by city that neighbors are encouraged to explore and utilize. npuatlanta.org

  - Summer evening trash pick-ups begin on Tuesday at 7:00 at Boxcar in the parking lot.
- Education
  - 626 items were donated through a pantry drive. \$3,044 dollars in total were donated
  - New partnership with the Partnership for Southern Equity who reached out to the Education Committee to work together, and donated 3 gift cards (\$150 each) to families in need in the West End
  - Trees Atlanta and The Overlook Boulder Gym have both contacted the Education Committee to identify ways to partner in the future once neighborhood schools reopen
