MEETING MINUTES

West End Neighborhood Development

January 14, 2014 (rescheduled from January 7, 2014 due to weather)

West End Library

The meeting was called to order by President Kimberly Parmer at 7:00pm.

Welcome and Introductions

The 2014 officers introduced themselves, followed by meeting attendees.

Overview of Meeting Protocols and Procedures

New Parliamentarian, Tony McNeal, provided a brief overview on WEND's goals for conducting general body meetings this year. We will focus on protocols observed in Roberts Rules of Order, and will try to streamline meeting length by assigning much of the organization's work to committees.

Approval of Meeting Agenda and Minutes from Last Meeting

A motion was made by Steven Barlow to approve the evening's agenda and the December 3, 2013 meeting minutes as presented. Alethea Parker seconded the motion. The vote was unanimous and the motion passed.

President's Report

President Parmer provided an overview of her vision for WEND in 2014. A summary of her report is presented below:

Moving FORWARD


Take 2001 LCI report and develop a condensed marketing plan for Historic West End. Use plan to engage commercial businesses that our demographic frequent on a consistent basis. This will require diligently fostering a relationship with the West End Merchants coalition. As well as engage businesses with WEND and possibly amend the historic district guidelines to include commercial development.

Participate in the following Quality of Life Projects:

- 1. Retrofit Atlanta- community based campaign
- 2. Keep West End Beautiful trash campaign/neighborhood clean up
- 3. Park Pride & Beltline park grants for upkeep or total renovation of West End Park, Howell Park and Rose Circle Garden
- 4. MARTA/COA Dept of Public Works traffic analysis study for traffic calming devices and removing MARTA bus routes off residential streets. Buses would be on perimeter of historic district.
- 5. Engage State & local resources for the following improvements to our district
 - A. Street Lighting Assessment & replacement.
 - B. Public Safety National night out, Zone 4 meeting, revisit neighborhood natrol.
 - C. Streetscapes improved sidewalks, street sweeping quotes & landscaping.
 - D. State representatives for GDOT entry and exit ramp beautification
 - E. APS Board Brown Middle School improvements
- 6. Develop composting and/or recycling program i.e. Tire recycling for playground matting

Announcements and A&A

- Steven Barlow raised questions of the Beautification Committee regarding refreshing the lighting and address sign poles on Peeples and Oglethorpe Streets. President Parmer indicated that the City is in the process of replacing street lighting based on a community audit performed last year. Karl Barnes added that the decorative light poles along this corridor are no longer manufactured. We will make an appeal for lighting to be address in other parts of the neighborhood.
- Alena Harrison reminded the body that WEND merchandise is available for purchase. The prices have dropped for WEND banners and street toppers.

- There was a question about bulk item and yard debris pickup. In some areas of our neighborhood, there hasn't been a pickup in over a month. President Parmer provided the following number to call 404.523.0632; the department manager's name is Calvin Stevens.
- Neighbors referenced a number of nonconforming business uses in the Historic district including a hair salon, day care center, and rooming houses. The Zoning and Land Use Committee will follow up on these violations. President Parmer also indicated that we are looking into finding pro bono legal representation to help us review and amend our bylaws, and to help assist with other legal violations in the community.
